2020 was the year that Caboolture Special School became a Special School focused on the education of primary school aged students. Prior to 2020, and since its establishment, Caboolture Special School has been a Prep - Year 12 Special School.

In 2020, the school population divided to become two separate schools –secondary year levels commenced at the new Lee Street State Special School and the primary years continued at Caboolture Special School. Our two schools have a distance of approximately 4 km between their campuses.

In keeping with educational research, the focus of the school curriculum has changed over the years to ensure currency and to best support the needs of students with a diverse and complex range of abilities. The school community looks forward to an exciting future with a focus on the Highly Individualised Curriculum under the Australian Curriculum Assessment and Reporting Framework. This was introduced in 2012 providing our students with multiple opportunities for learning. Currently, approximately 85% of our student cohort is engaged in learning in the Highly Individualised Curriculum, with approximately 15% of students learning in Year Level Partial – Years Prep and Year 1.

Students are placed into classes of between 4 and 7 students across the school. In 2020, the school was organized into four Clusters for the purposes of school organization. The allocation of students to classes was based on the review of the following information:

- Current of year level of achievement in the Australian Curriculum - including the Highly Individualized Curriculum
- Review of the overall student achievement data from semester 2- 2019
- Consideration of the most appropriate pedagogical practices to assist students in their learning
- Consultation with therapists around the most appropriate communication modes for student learning and the most applicable equipment and environments for students' access to learning
- Consultation with teaching teams around the Personal and Social Capabilities of students and small student groups

3. 2020 data was impacted by the COVID-19 health emergency. There were significantly fewer SDAs during the home-based learning period (the first five weeks of Term 2) compared to previous years.

## Staff profile

### Teacher standards and qualifications

The *Teacher registration eligibility requirements: Policy* (p.1) states:

To be eligible for registration, a person must satisfy the Queensland College of Teachers (QCT) that they meet requirements regarding qualification and experience, or have otherwise met the requirements of the *Australian Professional Standards for Teachers* (APST). A person must also satisfy the QCT that they are suitable to teach and meet English language proficiency requirements. All these requirements are specified in the Act and the *Education (Queensland College of Teachers) Regulation 2005* (the Regulation).

The qualifications required for teacher registration are successful completion of either -

- a four-year initial teacher education program including teacher education studies of at least one year (e.g. a Bachelor of Education, or a double Bachelor degree in Science and Teaching) or
- a one-year graduate initial teacher education program following a degree (e.g. a one-year Graduate Diploma of Education (Secondary) after a three-year Bachelor degree) or
- another course of teacher education that the QCT is reasonably satisfied is the equivalent of (a) or (b). These are considered on a case-by-case basis.

### Notes

1. The 2020 cohort was the first to complete Year 12 under the new senior assessment and tertiary entrance system. The new system has redeveloped senior syllabuses, strengthened school-based assessment, introduced a common external assessment in each senior General subject area and General (extension) and replaced the OP rank with the Australian Tertiary Admission Rank (ATAR). This represents a break in time-series for the Queensland Certificate of Education.
2. ATARs are calculated by Queensland Tertiary Admissions Centre (QTAC). ATAR data is not held by the department.
3. Prior to 2020, visa students (students who are not Australian citizens or permanent residents of Australia) were excluded. From 2020 visa students are included.

## Student destinations

The Queensland Department of Education conducts [annual surveys](#) that capture information about the journey of early school leavers and Year 12 leavers from school to further study and employment.

### Early school leavers

Schools work closely with a range of external agencies to support students who left school early.

Our Principal, Deputy Principal, Regional Transitions Officer or Guidance Officer liaises with early school leavers and their parents, providing a service 'beyond the school gate' to assist early leavers make a successful transition to other educational pursuits or employment.
